(INTERNATIONAL COMPETITIVE BIDDING)

(CORRIGENDUM -2)

The Scope of Work for the following packages and Bidder's Qualification Criteria mentioned in RFQ issued on 23.02.2008, Our Website and Corrigendum – 1 issued on 08.03.2008 is hereby modified as under:

2.0 SCOPE OF WORK OF BOP PACKAGE (S)

Packages 2.3 and 2.4 have been split as under:

2.3(a) Coal Handling Plant: -

Complete Package consisting of Wagon Tippler / Track hopper, Hopper, Stacker-cum-reclaimer, Crusher, Screen, Conveying system, and Civil and Structural work including Junction Tower, Crusher house, pent house, and conveyor galleries.

2.3(b) Ash Handling Plant: -

Complete Ash Handling System including Bottom Ash, Fly Ash System and Civil & structure work including Houses, fly ash silos & hoppers, pipe racks etc. for the proposed Thermal Power Plant on EPC Basis.

2.4 (a) Civil & Structural work for BTG: -

Station Building Structures and all civil works, Foundations of SG island equipment, misc. structures, pipe & cable racks, Coal bunkers / bunker bay structure and foundations, Transformer yard & switchyard for the proposed Thermal Power Plant on EPC Basis.

2.4 (b) Cooling Tower (NDCT / IDCT) :-

Natural Draft Cooling Tower / Induced Draft Cooling Tower for the proposed Thermal Power Plant on EPC Basis.

2.4 (c) Chimney: -

Double flue chimney with RC shell for the proposed Thermal Power Plant on EPC Basis.

2.5 General Civil & Structural Works: -

Township has been excluded from the scope of work of this package.

The bidders who have already submitted their Pre-qualification documents against complete packages as per RFQ need not submit the Pre-qualification documents again. However, the bidders

who are interested to participate in separate packages as indicated above and the bidders who fulfill the revised qualification requirement as per this corrigendum-2, may submit their Pre-qualification documents by the due date as mentioned below.

3.0 BIDDER'S QUALIFICATION REQUIREMENTS

The qualifying requirements for all packages as per RFQ and the split packages as per corrigendum-2 are modified as under: -

A. TECHNICAL

- (a) The bidder should have executed or in the process of execution of design, engineering, manufacturing, installation, testing and commissioning of at least One (1) package of similar nature for a Coal Based / Gas Based Power Plant of capacity 200 MW or above.
- (b) Deleted.

C. FINANCIAL

- (a) The Bidder shall have adequate financial resources to execute the Contract concurrently with his other commitments and shall meet the condition as mentioned in Sl.No. (b) below.
- (b) The Bidder shall have during the last three financial years an Average Annual Turn Over of not less than Rs.500 million (US\$ 12.5 million) or its equivalent in any other currency, for each package. For additional packages, the same will be in multiples thereof.

The due date for submission of Pre-qualification documents has been extended to 10.04.2008. The bidders are requested to submit two (2) sets of Pre-qualification documents.

All the other terms and conditions of RFQ shall remain the same.
